### GEORGIA CARES – MINOR VICTIMS

Georgia Cares is the single statewide victim service agency for child sex trafficking victims in Georgia. Georgia Cares manages a 24 hour hotline, conducts research based assessments and creates Individualized Care Plans, coordinates services, and supports child victims throughout their journey to treatment and restoration.
